Dear colleagues,

In celebration of 10 years of the European Healthcare Design (EHD) Congress, SALUS Global Knowledge Exchange and Architects for Health are delighted to welcome you to the Future Health 2050 International Symposium and EHD Champions Awards Live Judging and Dinner. Today's event combines a unique learning opportunity and reflection moment as we both look forwards to identify strategies for the future and backwards to embrace the lessons of the past.

With health systems around the globe under stress, during the morning session, our expert speakers will explore the investment and transformation strategies open to the NHS and identify the lessons learnt from how other countries are addressing challenges of rising demand, fewer resources and strained finances.

In the UK, Lord Ara Darzi has highlighted in his 'Independent Investigation of the NHS in England", how patient access to care, quality of care, and the overall productivity and performance of the NHS have been chronically weakened, laying the ground for a new 10-year plan in the Spring. Disastrous reforms, loss of trust and goodwill with frontline staff, the aftershocks of the pandemic and a chronic lack of capital investment, set against the backdrop of increasing demands on the health service and a deteriorating health of the nation, are cited as the cause of the NHS's "critical condition".

The UK Government has recognised that the NHS needs to make three big shifts in where, how and what it delivers, moving services: from hospital to the community; from analogue to digital, and from sickness to prevention. But what investment and transformation strategies are needed? Lord Darzi estimates a shortfall of $\pounds 37$ billion of capital investment, including a backlog maintenance bill now reported at $\pounds 13.8$ bn. The funding commitments in the Autumn budget announcement include a $\pounds 22.6$ billion increase in revenue and a $\pounds 3.1$ billion increase in capital over two years, with $\pounds 1$ billion to support backlog maintenance and the replacement RAAC hospitals, and $\pounds 1.5$ billion for new capacity. This is welcome but only scratches the surface of the challenge. What options are available to address the chronic underinvestment in capital?²

Set against this backdrop, what role can design also play? in the afternoon session, the project teams behind the design and delivery of 18 healthcare projects and previous winners of the EHD Awards, will present live to our judges as they compete to be awarded the EHD Champions of Champions, providing a novel opportunity to reflect on the design innovations and impacts that have set the standard in healthcare infrastructure over the last ten years. The day will culminate with the awards ceremony in the evening, where the most impactful projects will be celebrated and the winners will be revealed. See pages 9-21.

With health systems around the world facing similar challenges, we're excited to welcome participants from around the world today to share how different global approaches to policy, planning and investment alongside case examples of healthcare design innovation from our 18 Champions award-winning projects can help shape the health systems and infrastructure of the future.

Unbroken: A call to invest

Three years on from Russia's invasion, against all odds, Ukraine's people remain resilient and defiant. In her keynote awards dinner address, Mariana Svirchuk updates the story of Ukraine's National Rehabilitation Centre, Unbroken and invites the world's healthcare design community to support its cause.

New and challenging emotions were aroused at last year's 10th European Healthcare Design Congress in response to Mariana Svirchuk's vivid and powerful keynote address that grounded delegates attending in the reality of healthcare provision in a conflict zone.

Established by the First Lviv Medical Union and the Lviv City Council with the support of the Ministry of Health of Ukraine, Unbroken is more than just a rehabilitation centre.

It is a unique ecosystem of humanity that unites more than twenty projects, including two adult hospitals, two rehabilitation centres, one maternity hospital and one children's hospital providing a variety of services, including treatment, prosthetics, physical and psychological rehabilitation, housing, and reintegration.

Since the war began, 1861 hospitals have been destroyed across Ukraine and over 650 children have died, with many thousands more young people injured. The city of Lviv has turned into a huge humanitarian hub in which people fleeing the war find refuge. Among the Centre's areas of work are reconstructive surgery, orthopaedics and prosthetics. People are not only fitted with prostheses, they are made there. In addition, the Centre deals with physical, psychological and psychosocial rehabilitation.

Since the invasion, Unbroken has treated 1.5 million casualties, performed 68,000 surgical interventions, fitted 225 prosthetics, rehabilitated 6,985, and provided 17,000 mental health consultations.



Saving young lives: Operating theatre reconstruction

St Nicholas Hospital is the 440-bed children's hospital, treating and operating on children from as little as 500 grams in weight up to 18 years old. It serves patients in pediatric, surgical, neurological, and rehabilitation departments. The neonatology center, with its own intensive care unit, assists newborns requiring specialised long-term care. 150,000 displaced persons currently reside in Lviv, of whom 70,000 are children, all requiring medical assistance.

The operating block of the hospital performs complex surgeries daily, saving the lives of young patients. However, despite immense efforts, this vital operating unit is in urgent need of reconstruction. The operating block is in an extremely poor condition; the equipment is outdated and often malfunctions, complicating surgical interventions and reducing the quality of care provided. Ventilation and sterilization systems do not meet modern standards, posing risks to both patients and medical staff. Many areas require major repairs, as their technical condition fails to meet the required standards of safety and comfort.

To provide the best possible care, the operating block urgently needs reconstruction and equipping with stateof-the-art medical equipment and furniture. At a total cost of Euros 1,628,000 (Euros 407,000 per theatre), the project has the following key requirements:

- > Renovation of the operating block: Reconstruction of the four operating theatres to ensure they meet modern safety and comfort standards.
- Purchase of essential medical equipment and furniture: To enhance the precision and quality of surgical procedures, all theatres require upgrading with new operating tables, lighting systems, and other critical items.
